Intellectual Property Rights (IPR) is concerned with the protection of tangible and intangible property. It provides rewards and recognition to inventor(s)/contributor(s) for their research, designs, discoveries and inventions etc. The aim is to train the participants about the mechanism of accessing and using IPR information for further research and development in developing new products and processes and for their use in business development. Also suggest steps for transforming innovations into proprietary assets.

- Procedures of patent searching using national/ international databases.
- Procedures of patent filing in India as well as abroad.
