**1. JOB DESCRIPTION:**

- ✓ You would be required to teach theory courses and Laboratory courses either Online or Offline as per the requirement of the University.
- ✓ It is desirable that you will publish at least one conference paper and one article in a referred journal per year.
- ✓ It is desirable that as a advisor/ mentor, you would guide faculty members of your school to take up at least one R&D / Consulting / extension project in your area of expertise per year. However all such projects must be prior approved by the Dean of School and must be routed through the University.
- ✓ Any other work responsibility entrusted by the institute from time to time in the interest of the Institute/University.

**2. REMUNERATION :**

- ✓ You will be paid a monthly Consolidated remuneration of **Rs.25,000/-** (Rupees Twenty Five Thousand only) per month.

**3. REVISION CLAUSE :**

- ✓ This appointment is valid for a period of One Year.
- ✓ The appointment will be reviewed and renewed after one year based on the performance and vacancy.
- ✓ The renewed appointment could either be a simple renewal, or a renewal with review of terms including the remuneration.

**4. SEPARATION :**

- ✓ The employee can separate from this contract with mutual consent by giving one month's notice on either side.
