Ms. Nehashree Samrat is a bright student of BSc MRT final year. She has a CGPA of 8.5 till 4th Sem (with an SGPA above 8 points in each sem; 5th Sem results are awaited).

As per my interaction with her, Ms. Nehashree Samrat is pursuing her BSc MRT degree through a Study loan from Bihar Credit loan. She was sanctioned with Rs. 4,00,000 (Academic fee + Hostel fee) from the bank.

Break up for sanctioned study loan:

1st Year: Rs 90,000 (Academic fee)

2nd Year: Rs 1,55,000 (i.e. Rs 90,000 Academic fee + Rs 65,000 Hostel fee)

3rd Year: Rs 1,55,000 (i.e. Rs 90,000 Academic fee + Rs 65,000 Hostel fee)

As informed by the student, all the above fees have already been credited to the account of CUTM from the bank (Details of the transaction are attached)

Issues:

1. The student is asked to pay Rs 4000 hostel fee (for Aug- Sept, 2021). The student had not reported to the campus during that period due to the demise of her father in the month of July, 2021. She is requesting to forfeit Rs 4000 as she had not reported to the hostel. She rejoined the hotel on 15th October 2021 and has paid the hostel fee from Oct- Dec 2021 (through the study loan from the bank).

2. As there was a delay from the bank in sending the loan for the 3rd-year academic fee, she had to pay Rs 45,000 (copy of the receipt attached) from her own resources.

Later CUTM has received Rs. 1,55,000 from the bank (details attached), but the expenses were Rs 1,18,000. Break up:
