A well defined lesion with few calcific foci within is seen in anterior segment of right upper lobe, measuring 7.2x3.8 cm in size.

Bronchus involvement: It is extending into right upper lobe bronchus (Se: 3, lma :178 )

Vascular involvement: Posteriorly it is abutting right pulmonary artery at bifurcation into upper and lower lobe branches.

It is abutting pericardium anteriorly adjacent to left atrium with indistinct fat plane.

Fat plane with SVC and ascending aorta is well maintained.
