Constraints in Cashew nut Entrepreneurship in India and Suggestive Measures

1. Introduction

Over the past decade the new entrepreneurial endeavours have grown rapidly in India. The government has extended a helping hand in this effort through some of the most effective programmes like Stand up India, Start-up India, Make in India and Mudra scheme etc. The India entrepreneurial sector, with the active support from the government is capable of grooming the youth to be successful entrepreneurs.

Development of agribusiness sector is vital for uplifting the economic situation of the rural people. Rural entrepreneurship has been identified as areas of new research to bring out the development of the agribusiness sector (Vijay, S. 2016). The task of developing entrepreneurship in the cashew processing sector quickly, seems encouraging as this sector falls under the category of agro-based industry, which attracts a preferential treatment from the government. The main stages in the cashew processing are shelling, peeling and grading. These processes are primarily performed by women. Women usually sit for seven to eight hours a day in a squatting position to perform these processes. Squatting for such long hours on a daily basis causes them to develop pain in backbone, knee and stomach. During the shelling process a
