Name of the Activity: Industry leadership talk “Current Trends and Scope of Agribusiness”.

School of Management in collaboration with M.S. Swaminathan School of Agriculture, Centurion University of Technology & Management – Odisha has organized an Industry leadership talk “Current Trends and Scope of Agribusiness”.

Speaker 1: Mr. Kuchibhotla Srinivas, Partner, Food, Agri & Retail Practice, KPMG India

The resource person started with an overview of Agribusiness consulting. Then he discussed about the overall landscape of agribusiness in India and finally he discussed about the role of KPMG India.

Speaker 2: Mr. Anand Chandra- Executive Director, Arya.ag
Mr. Anand started his discussion with the Significance of Agriculture in India (GDP, Employment Generation): 15% to the country's GDP and employs more than 55% of the population. He also stated that SMF is the largest segment (Land Holding is going to impact the adoption of new technologies and there is the need of aggregation): More than 85% of the Indian farmers are SMF and over 40% of the country's operational land holdings are with SMF. Then he continued his discussion further into regional imbalances in the country.

Speaker 3: Mr. Abdul Moshawir, Regional Head, Priority sector lending Business in Odisha

Some of the highlights of his discussion can be summarised as follows:

- ▲ Indian Economic Scenario: Around 42% of the workforce is engaged in agriculture contributing to 16% of the country's GDP. This is leading to the low per capita income of the agriculturists in India.
- ▲ Snapshot of Indian Agriculture: India has one of the highest farm outputs in the world, 179 million hectares of cultivable land and one of the largest contributors of rural output and employment in the country.
- ▲ Skill sets required to be an agribusiness financier: Understanding of the agribusiness industry, market dynamics, financial analysis & communication skills; opportunities lie in product, credit, audit, technology, business development, etc.
