The Disciplinary Committee under the Chairmanship of Prof. Jagannath Padhi, Director, Bhubaneswar Campus met on 20.11.2021 at 04.00 pm in Room no- 104 to hear the complaint lodged by the Dy. Security Officer, Victims of the incident and Administration against the accused student Sri. Mahaprasad Mohanty (Student of 1st year Electrical ITI).

During the meeting the following points were discussed:

The Convener, DC welcomed all the members and appraised about the incident happened and steps taken so far as mentioned below.

- The accused student Sri Mahaprasad Mohanty (Student of 1st year Electrical ITI) thrown stones to the University Bus No. OR-02-AY 8014 on 21st Oct. 2021 at 9.00 AM at the Main Entrance Gate without any reason. This resulted in physically damaging the bus and injuring 03 of our Staff and Faculty Members.




- An internal enquiry and action was initiated immediately by the Administration in presence of ITI academic people and the parents of accused were informed to report to the campus.
- The paternal uncle of the accused Mr. Guru Prasad Mohanty came and accepted that the accused is having some mental related issue and apologized for the incident.
- He has taken back the accused to his home safely and given in writing that such incident will not happen in future but he had shown his inability to compensate the damage.
- Based on the advice of the local Police station the FIR has not been lodged and the incident forwarded to the Disciplinary Committee of the University for Further action.
- We tried to contact, over phone, the accused, his parents and family members. We found all mobiles are in switched off mode.
- Therefore we sent an official letter to him through speed post (attached the postal Details) on 29th Oct. 2021 asking him to face the Disciplinary Committee on 6th Nov. 2021 at 4PM in Room No. 5 was received by him on 1st Nov. 2021 as per the India post status.
- As the accused didn't come to present before the Disciplinary Committee on the above mention date, the committee decided to gave him a last chance to appear before the Disciplinary Committee and accordingly the final letter was sent to him.
- The paternal uncle of the accused Mr. Guru Prasad Mohanty appeared before the Disciplinary Committee and informed that due to the mental illness he couldn't brought the accused Mahaprasad Mohanty.
- He apprised the Disciplinary Committee that his nephew has developed mental illness and behaving abnormally at their home.
- He has shown the medical prescription of a Psychiatrist which was prescribed for the accused on dated 21.11.2021.
- He has expressed his inability to bring his nephew to the Disciplinary Committee and apologized for the miss conduct.
- Based on his previous involvement in indiscipline activity and the punishment given, the Disciplinary Committee resolved for the following

1. Compulsory TC to be issued to the accused.

2. Suspension from the Institute for One year. *and will review after one year*











The Disciplinary Committee under the Chairmanship of Prof. Jagannath Padhi, Director, Bhubaneswar Campus met on 28.04.2022 at 04.00 PM in Room no- 5 to hear the complaint lodged by the Victim of the incident Sri. Suraj Samantaray (1<sup>st</sup> year MCA - 210720100069) and Deputy Security Officer against the accused students Sri. P. Pawan Kumar (2<sup>nd</sup> Year Diploma Mech - 201207120001) Sri. Ashish Nath (2<sup>nd</sup> Year BTech EEE - 200301150014).

During the meeting the following points were discussed:

The Convener, DC welcomed all the members and appraised about the incident happened and steps taken so far as mentioned below.

- The Victim of the incident Sri. Suraj Samantaray (1<sup>st</sup> year MCA - 210720100069) has verbally complained (he was found to be in bad physical condition & bleeding at his neck and also nervous due to fear) in person to the Convenor, DC on the



date of incident i.e., 29<sup>th</sup> March 2022 around 7.30 PM at the university campus followed by a written complaint on 31<sup>st</sup> March 2022.

- Then preliminary inquiry made by the Convenor, DC collecting information from various sources and found that the complaint seems to be a fact. Also, on the first day of the Annual Function i.e., on 31<sup>st</sup> March 2022, in one incident occurred near the stage, the names of both accused were reported by the *Dy. Security Officer.*

- A quick action was initiated immediately by the Convenor, DC through the Dy. Security Officer by restricting the entry of both accused till the completion of the Annual Function.

- Both the accused came to campus on 5<sup>th</sup> April 2022 and appeared before the Convenor, DC and refused that they didn't come to campus on 29<sup>th</sup> March 2022 and don't even know about the accused student nor incident happened.

- Both the parents were informed about the same by the Convenor, DC immediately in front of the accused and they were requested to counsel their respective wards for the incident happened. They all agreed to the suggestion.

- The Deputy Security Officer complained against both the accused that they had argument with the on-duty Security personnel on 29<sup>th</sup> March 2022 around 7PM when asked to show their ID proof and threatened of dire consequences too.

- Both the academic heads of these two students were informed of the incident and it was revealed that they are also involved in more than one indiscipline cases before and they are regularly irregular to their classes.

- The committee found that Ashish has not done subject registration by paying the academic dues for last two semesters and therefore having 0 % attendance in all subjects at the end of the semester. Pawan has less than 25 % attendance in all subjects.

- Based on the preliminary investigation made, the DC meeting was called by the Convenor, DC on 12<sup>th</sup> April 2022 at 3PM. All the accused, victim and witnesses of the incident were instructed over the email notification and telephone call to appear before the DC.

- The mobile phone of Ashish was received by his mother and passed on to his father and he said that his ward is not available at home one day after the incident happened. Pawan received the call and confirmed that he will be there before the DC.

- During the meeting, the committee found both the accused *absent.* The verbal and written statements of the victim and witnesses were recorded before the DC.

- Mr. Anjan Nath, the father of Ashish came to attend the DC as his son was not available. He found to be unaware of all the information related to his son related to academics, fees, exam etc.



- As the accused didn't come to present before the Disciplinary Committee, the committee decided to give him a last chance to appear before the Disciplinary Committee without fail otherwise decision will be taken accordingly.
- Therefore, we had sent an official letter through speed post (attached the postal Details) along with email notification, SMS and telephone call to them on 19th April 2022 asking them to face the Disciplinary Committee on 28th April 2022 at 4PM in Room No. 5 without fail.
- The mobile phone of Ashish was received by his mother and told that his father will attend the meeting as Ashish is not available at home one day after the incident happened. Pawan and his father                      did not responded to the phone call.
- As both the accused didn't come to present before the Disciplinary Committee on the above mention date, the committee understood the matter and confirmed the involvement of both the accused.
- Based on the previous involvement of both accused in indiscipline activity and non-involvement in academic activity, the Disciplinary Committee resolved for the following:



He had intoxicated Ms.snigdha with a cold drink served in Paralakhemundi and took to his village at Gujarat. Further, she didn't remember any event in between.
- 5)Parents described that Ms.Snigdha Mandal is now mentally upset and she is recovering from trauma.
- 6) During the meeting the deliberation focused on possibilities of her study and stay at CUTM. Based on this discussion following action has been agreed.

- 4) The committee strongly feels that they should not work under a same department.
- 5) It seems the issues of conflict are deep rooted and need to be investigated However it was beyond the ambience of the committee.
- 6) Mr. Rabindra Nath Patro is guilty of saying wrong things to his superior officers during office hours, whatever could be the reason and circumstances, it is not acceptable.
- 7) Mr. Rabindro Nath Patro expressed his concern about Mr. Pramod Kumar Panigrahi is consuming liquor and at times different to many officials. It may be thoroughly investigated.
- 8) Financial penalty, change of work place and mutual settlement between the two office bearers have been suggested by the committee for immediate implementation.
