MOU FOR WET WASTE MANAGEMENT

This MOU for Waste Management is entered into on 24-09-2017 by and amongst,

ASANALA RAMU Residing at Parlakhemundi, Gajapati district -761211, (herein after referred as "ASANALA" which expression shall unless contrary to the context or meaning thereof, mean and include its successors and permitted assigns) represented by Shri ASANALA RAMU

AND

Centurion University of Technology and Management (CUTM) having its Registered Office/ Principal Office at Rajaseetapuram, Odisha 761211, Bhubaneswar (herein after referred to as the "CUTM", which expression shall unless repugnant to the context or meaning thereof, mean and include its successors and permitted assigns) represented by Dr. Durga Prasad Padhy, Dep.Registrar, CUTM duly authorized vide President of the University.

WHEREAS;

- ASANALA is operating a service for the collection, transportation, channelization of wet waste/Food waste of the university to feed his piggery unit.
- CUTM & ASANALA have agreed to partner for wet waste management and channelization of Wet Waste or Food waste in accordance with the terms of this MOU.

NOW THIS AGREEMENT witnesses as

follows; DEFINITIONS AND

INTERPRETATION

1. Wet Waste – Will refer to the following kinds:
 - a. Waste obtained from non cooked food, cooked food, processed food and spoiled food.

SCOPE OF THE AGREEMENT

Responsibility of ASANALA

- To help in establishing the processes for channelization of all wet Waste.
- To support with awareness programs on wet waste management.

Responsibility of CUTM:

- To Form a Waste Management committee.
- To Organize in house activities related to waste management.
- To identify and segregate all kinds of Waste generated in all the campuses across CUTM.
- To coordinate with ASANALA for channelizing Wet Waste in compliance with the national laws and regulations.

TERM AND TERMINATION

1. This Agreement shall be in force for a period of 10 years from the date of signing of this Agreement. Upon completion of the term, the Agreement may be renewed at the option of both the Parties in writing on mutually agreed terms and conditions.
2. The Agreement may be terminated by either party by giving 3 months of prior written notice to the other Party.
