This is to informed you that CUTM has strict "Zero Tolerance' towards any form of ragging as described in this Supreme Court judgment. Ragging is strictly banned in college premises and anybody found indulged in such activities will be strictly punished.

Ragging is an offensive and demeaning practice imported from abroad and is contrary to our cultural ethos. CUTM has a Zero tolerance policy towards ragging, & this practice will be curbed by the administration at all costs. Interrogation of fresher, instigation to rag, threatening and ill treatment of fresher will be treated as act of ragging along with indulging in actual ragging in any form, shape, grab or guise committed either inside or, outside the hostel or institute. Ragging is a serious offence which will result in serious disciplinary action including rustication. To curb ragging the help of whole administration will be taken.

**The Anti-Ragging Squad** will work to checking places like Hostels, Buses, Canteens, Classrooms and other places of student congregation, for any incidences of Ragging, and shall educate the students at large in the University about Menace of Ragging and related Punishment Provisions.

Any case of Ragging that is observed or reported will be dealt by the Anti-Ragging Cell. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Cell of the University, the **possible punishments** for those found guilty of ragging at the University level shall be any one or a combination of the following:

1. Cancellation of admission

2. Suspension from attending classes

3. Withholding/withdrawing scholarship/fellowship and other benefits

4. Debarring from appearing in any test/examination or other evaluation process

5. Withholding results

6. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.

7. Suspension/expulsion from the hostel

8. Rustication from the institution for a period as may be determined by appropriate authority

9. Expulsion from the institution and consequent debarring from admission to any other institution of the University

10. Fine of Rupees 25,000/-

#### D. O. No. F. 1-15/2009 (ARC) pt.III

Dear Madam/Sir,

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". The Regulations are available on the UGC website i.e. <u>www.ugc.ac.in</u>.

It is once again brought to your kind notice that ragging is a criminal offence and UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. These regulations are mandatory and all institutions are required to take necessary steps for its implementation in toto including the monitoring mechanism and any violation of these regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by the UGC.

You are requested to step up anti-ragging mechanism by way of adequate publicity through various mediums; constitution of anti-ragging committee and anti-ragging squad, setting up of Anti Ragging Cell, installing CCTV cameras at vital points, Anti-ragging workshops and seminar, updating all websites with nodal officer's complete details, alarm bells etc. Regular interaction and counseling with the students, identification of trouble-triggers and mention of Anti-ragging warning in the institution's prospectus and information booklets/brochures shall be ensured. Surprise inspection of hostels, students' accommodation, canteens, rest cum recreational rooms, toilets, bus-stands, display Anti Ragging posters at all prominent places like Admission Centre, Departments, Library, Canteen, Hostel, Common facilities etc. These posters are available on UGC website <u>www.ugc.ac.in.</u> The size of posters should be 8x6 feet. Any other measure which would augur well in preventing/quelling ragging and any uncalled for behaviour/incident shall be undertaken.
