

finds any document unclear or irrelevant, they may demand the candidate to re-upload the same. **The time permitted for re-uploading will be till 12noon of next calendar date (from the date of demand).** So it is better that candidate leaves no lapses in the uploaded documents in order to avoid the requirement of re-submission. Scanned images (JPEG files) of the original documents [mentioned at Item 4.1.1 of AIEEA (PG)-2020 Online Counseling Brochure] are required to be uploaded on the counseling portal at the time of counseling.

For admission in M.V.Sc., candidates must have completed B.V.Sc. & A.H. with internship at the time of online verification of documents by the allotted university. However, in view of COVID-19 pandemic, B.V.Sc. & A.H. candidates have been given a one-time relaxation in submission of PDC up to 31.12.2021 for counseling. Such candidates, however, shall be mandatorily required to upload a certificate from the Registrar of the concerned university specifically indicating that *the candidate has been awarded Final OGPA/Percentage of marks at the end of final semester/year and he/she shall be completing all the requirements including internship for the award of B.V.Sc. & A.H. degree before 31.12.2021 along with mentioning the likely date of issuance of PDC/Degree to the candidate" in case of 5 years and at the time of registration in case of 5½ years.* 

In case any degree from a particular college/university is not considered for admission by an Agricultural University on account of a particular college/university being derecognized by VCI/UGC, or due to any court directives (present or future), ICAR will not be held responsible for admitting students of that college/university in the Universities not willing to admit such candidates.

The candidates passed out from colleges/universities, whether private or Govt. but not accredited by ICAR (except few courses of Dr. RPCAU Pusa and RLBCAU Jhansi), even though affiliated to public funded/Govt. institutions or constituent, were notified through Information Bulletin, as not eligible to appear in AIEEA (PG) examination. Therefore, if any of such candidates have appeared in the examination and their scores declared by NTA, are not eligible to participate in the counseling. ICAR will not be held responsible for denying admission to such ineligible candidates by any of the accredited AU under the ICAR-AU system.

The exact title/nomenclature of the degree programme might vary from one university to another. To get ICAR- PG Scholarship, the candidate must pursue Master's degree from an AU in a state different from the one where the AU of his /her Bachelor's degree is located, i.e. AUs of Bachelor's degree and Master degree should be located in different states. This condition, however, shall not apply for admission to NDRI, Karnal, RLBCAU, Jhansi and Dr. RPCAU, Pusa where admissions to 100% seats of Bachelor's degree programme are made on the basis of All India Entrance Examination conducted by ICAR and to B.V.Sc. & A.H. candidates passed out from IVRI, Bareilly seeking admission to Master's degree programme at IVRI, Bareilly through AIEEA(PG)-2021 subject to fulfilment of other prescribed requirements for the award of ICAR-PG scholarship.

The non- PG Scholarship candidates shall be eligible to get NTS (PGS) of Rs. 5000/- per month for two years provided they join Master degree programme in an AU located in a state different from their state of domicile. Even the candidates who do not want to avail NTS (PGS) have to mandatorily seek admission in an AU different from the one from where they have graduated.

The award of PG scholarship and NTS (PGS) shall be governed by the rules and regulations issued and as amended by the Council from time to time in this regard. After the admission, under no circumstances, the request for change of subject and the university will be entertained from the candidates/parents.

#### It may be noted that ICAR/University will NOT be held responsible for denial of admission to noneligible or non-reporting candidates due to any reasons.







Based on the result of the ICAR's 25<sup>th</sup> All India Entrance Examination [AIEEA(PG)-2020], for admission to Master degree programmes in agriculture and allied sciences on 25% seats in accredited State Agricultural Universities (SAUs), CAU, Imphal, BHU, Varanasi, AMU Aligarh, SASARD, Nagaland University and 100% seats at IARI, IVRI, NDRI, CIFE, RLB CAU Jhansi and Dr. RPCAU Pusa, Bihar in the Academic Session 2020-21, this is to inform that **you have been found eligible to register (online) for choice filling.** Based on Online Counseling in the subject of your choice, you are likely to be recommended for admission to an accredited subject and College in an accredited University. This will, however be subject to fulfilling of the prescribed eligibility requirements as stipulated in the AIEEA (PG)-2020 Information Bulletin available at <u>www.icar.nta.nic.in</u> and Online Counseling Brochure available at <u>www.icarexam.net</u>. This will also depend upon the availability of seats at your merit rank and category and verification of documents by the officials of admitting University at the time of counseling and your physical reporting at the finally allotted university for registration/attending the classes or as per the requirements of admitting university. Subject to meeting of prescribed eligibility criteria of UR (Unreserved) category, the SC/ST/Gen-EWS/UPS/OBC/PC candidates may be allotted seat against the UR category.

Before registering for choice filling, you must ensure that all the eligibility conditions, as specified in the AIEEA (PG)-2020 Information Bulletin (IB) available on NTA website (www.icar.nta.nic.in) and online counseling brochure are fulfilled in toto including completion of the degree, OGPA/percentage marks scored in Bachelor's Degree examination, etc. (Where OGPA is awarded, equivalence between OGPA and % marks will not be acceptable).

Please note that ICAR/Universities will NOT be held responsible for denial of admission to non-eligible candidates. The candidate is advised to read the IB in detail and especially the Item 4.0 (Admission through Online Counseling) of Online Counseling Brochure of AIEEA (PG)-2020, and the requirements contained therein.

The candidate should note that having 4/5 (B.V.Sc.& A.H.)/6 (10+6, B.Sc. Ag.) years' UG degree is the essential requirement for admission to Master degree programmes. The candidates having passed with 3 years' UG degree programme are not eligible for admission through AIEEA (PG)-2020 except at IARI and NDRI in few courses.

Scanned images (JPEG files) of the original documents [mentioned at Item 4.1.1 of AIEEA (PG)-2020 Online Counseling Brochure] are required to be uploaded on the counseling portal at the time of counseling.

For admission in M.V.Sc., candidates must have completed B.V.Sc. & A.H. with internship at the time of online verification of documents by the allotted university. However, in view of COVID-19 pandemic, B.V.Sc. & A.H. candidates have been given a one-time relaxation in submission of PDC up to 31.12.2020 for counseling. Such candidates, however, shall be mandatorily required to upload a certificate from the Registrar of the concerned university specifically indicating that *the candidate has been awarded Final OGPA/Percentage of marks at the end of final semester/year and he/she shall be completing all the requirements including internship for the award of B.V.Sc. & A.H. degree before 31.12.2020 along with mentioning the likely date of issuance of PDC/Degree to the candidate"*.

In case any degree from a particular college/university is not considered for admission by an Agricultural University on account of a particular college/university being derecognized by VCI/UGC, or due to any court directives (present or future), ICAR will not be responsible for admitting students of that college/university in the Universities not willing to admit such candidates.

The candidates passed out from private agricultural colleges/universities not accredited by ICAR, even though affiliated to public funded/Govt. institutions, were notified through Information Bulletin, as not eligible to appear in AIEEA (PG)-2020 examination. Therefore, if any of such candidates have appeared in the examination and their scores declared by NTA, are not eligible to participate in the counseling. ICAR will not be held responsible for denying admission to such candidates by any of the accredited AU under the ICAR-AU system.

The exact title/nomenclature of the degree programme might vary from one university to another. The candidate is advised to enquire about the nomenclature of degree programme and other details from the Registrar of the concerned university [for contact details, please refer Annexure-III of Online Counseling Brochure of AIEEA (PG)-2020 before registering for online counseling/seeking admission.

Against total number of ICAR seats available for a particular degree programme in a university, not more than 40% of ICAR seats from one State would be allocated to any one university in that Sub-subject under a particular

category. While computing 40% number, mathematical method of rounding to the nearest integer would be adopted except where there is only one seat, in which case, the whole seat would be allocated. While rounding off, the number might exceed 40% to that extent.

To get ICAR- PG Scholarship, the candidate must pursue Master's degree from an AU in a state different from the one where the AU of his /her Bachelor's degree is located, i.e. AUs of Bachelor's degree and Master degree should be located in different states. This condition, however, shall not apply for admission to NDRI, Karnal, RLBCAU, Jhansi and Dr. RPCAU, Pusa where admissions to 100% seats of Bachelor's degree programme are made on the basis of All India Entrance Examination conducted by ICAR and to B.V.Sc. & A.H. candidates passed out from IVRI, Bareilly seeking admission to Master's degree programme at IVRI, Bareilly through AIEEA(PG)-2020 subject to fulfilment of other prescribed requirements for the award of ICAR-PG scholarship.

The non- PG Scholarship candidates shall be eligible to get NTS (PGS) of Rs. 5000/- per month for two years provided they join Master degree programme in an AU located in a state different from their state of domicile. Even the candidates who do not want to avail NTS (PGS) have to mandatorily seek admission in an AU different from the one from where they have graduated.

The award of PG scholarship and NTS (PGS) shall be governed by the rules and regulations issued and as amended by the Council from time to time in this regard. After the admission, under no circumstances, the request for change of subject and the university will be entertained from the candidates/parents.

#### It may be noted that ICAR/University will NOT be held responsible for denial of admission to noneligible or non-reporting candidates due to any reasons.

#### Schedule for online counseling:

The candidate may please note that the online counselling portal will be available for registration, choice filling and saving the choices as per schedule. The candidate is advised to carefully go through the major steps involved in Online Counselling enclosed with this letter.

Before exercising the option of choice filling, the candidate will have to get registered by paying Non-Refundable Registration Fee of Rs. 500/- through online payment gateway of ICAR by using Credit Card/RuPay Debit Card/Netbanking/UPI. Before registering for choice filling, you must ensure that all the eligibility conditions, as specified in the AICE-JRF/SRF(Ph.D.)-2021 Information Bulletin (IB) available on NTA website (<u>www.icar.nta.nic.in</u>) and online counseling brochure, are fulfilled in *toto* including completion of the degree, OGPA/percentage marks scored in Master's Degree examination, etc. (Where OGPA is awarded, equivalence between OGPA and % marks will not be acceptable). Please note that ICAR/Universities will NOT be held responsible for denial of admission to non-eligible candidates. The candidate is advised to read the IB in detail, especially the Item 4.0 (Admission through Online Counselling) of Online Counseling Brochure of AICE-JRF/SRF (Ph.D.)-2021 available at ICAR website (<u>www.icar.org.in,www.icarexam.net</u>) and the requirements contained therein.

Scanned images (JPEG files) of the original documents [mentioned at Item 4.1.1 of AICE-JRF/SRF (Ph.D.)-2021 Online Counseling Brochure] are required to be uploaded on the counseling portal at the time of counseling.

Candidates reporting for the admission must have Degree/Provisional Degree Certificate (PDC) of completion of Master's degree programme at the time of online verification of document by the allotted university. The candidates who do not have the Degree/PDC, have to mandatorily produce a certificate from the Registrar of the concerned university specifically indicating that *the candidate has been awarded Final OGPA/Percentage of marks at the end of final semester/year and he/she shall be completing all the requirements including thesis submission and completion of viva-voce for the award of Masters degree before 31.12.2021 along with mentioning the likely date of issuance of PDC/Degree to the candidate.* 

The candidate should note that having 4/5 (B.V.Sc.& A.H.)/6 (10+6, B.Sc. Ag.) years' UG degree is the essential requirement for admission to Master degree programmes. The candidates having passed with 3 years' UG degree programme are not eligible for admission through AICE-JRF/SRF (Ph.D.)-2021 except at IARI and NDRI in few courses.

In case any degree from a particular college/university is not considered for admission by an Agricultural University on account of a particular college/university being derecognized by VCI/UGC, or due to any court directives (present or future), ICAR will not be responsible for admitting students of that college/university in the Universities not willing to admit such candidates.

The candidates passed out from private agricultural colleges/universities not accredited by ICAR, even though affiliated to public funded/Govt. institutions, were notified through Information Bulletin, as not eligible to appear in AICE-JRF/SRF(Ph.D.) examination. Therefore, if any of such candidates have appeared in the examination and their scores declared by NTA, are not eligible to participate in the counseling. ICAR will not be held responsible for denying admission to such candidates by any of the accredited AU under the ICAR-AU system.

The exact title/nomenclature of the degree programme might vary from one university to another. The candidate is advised to enquire about the nomenclature of degree programme and other details from the Registrar of the concerned university [for contact details, please refer Annexure-III of the Online Counseling Brochure of AICE-JRF/SRF(Ph.D.)-2021 before registering for Choice filling /seeking admission.

Against total number of ICAR seats available for a particular degree programme in a university, not more than 40% of ICAR seats from one State would be allocated to any one university in that Subject under a particular category. While computing 40% number, mathematical method of rounding to the nearest integer would be adopted except where there is only one seat, in which case, the whole seat would be allocated. While rounding off, the number might exceed 40% to that extent.

Fellowship would be granted only when the candidate seeks admission after counselling and pursues Ph.D. degree in an AU other than the AU from where he/she has completed Bachelor's or Master's degree as indicated in the Information Bulletin and Online Counseling Brochure. The candidate is advised to go through Item 7.0 [Conditions for the award of ICAR-JRF/SRF(Ph.D.)] of the Online Counseling Brochure in this regard. The award of Junior Research Fellowship/Senior Research Fellowship [JRF/SRF(Ph.D.)] shall be governed by the rules and regulations/guidelines issued and as amended by the Council from time to time in this regard.

# It may be noted that ICAR/University will NOT be held responsible for denial of admission to non-eligible or non-reporting candidates due to any reasons.

### Schedule for online counselling:

The candidate may please note that the online counselling portal will be available for registration, choice filling and saving the choices as per schedule. The candidate is advised to carefully go through the major steps involved in Online Counselling enclosed with this letter.

Before exercising the option of choice filling, the candidate will have to get registered by paying Non- Refundable Registration Fee of Rs. 500/- through online payment gateway of ICAR by using Credit Card/RuPay Debit Card/Netbanking/UPI. The candidate must fill the choices well in time on or before the deadline of choice filling. The contents of the form/choices as filled by the candidate on the portal will get locked automatically after this deadline.



finds any document unclear or irrelevant, they may demand the candidate to re-upload the same. **The time permitted for re-uploading will be till 12noon of next calendar date (from the date of demand).** So it is better that candidate leaves no lapses in the uploaded documents in order to avoid the requirement of re-submission. Admission will be denied if the candidate fails to upload the desired document within permitted time window. If a candidate is denied admission, then he/she will NOT be considered in the subsequent round.

After documents are declared "Verified" by the University, candidate has to pay "Seat Acceptance fee" of Rs 10,000. This is to be paid by all candidates of all categories. Although this fees is non-refundable but due to Covid-19 pandemic situation, a candidate will get 100% refund if requested up to completion of Third Round of counselling i.e. END of Fee Reconciliation and Online Reporting by the Universities. If refund is requested after completion of Third Round, then there WILL BE a deduction of Rs 1,000/-. In "Upgraded" cases, the candidate will not be required to pay the "Seat Acceptance Fee"

<u>again.</u>

At this stage candidate will also be required to opt for "Upgradation" if he wishes to. "Upgradation" is the process to shift the candidate to his/her better choice in subsequent round of allotment (Except in last round). If an upgraded seat is allotted in the subsequent round then the candidate will have no claim left on the earlier allotted seat. So this option must be exercised carefully.

After reconciliation of Seat acceptance fee, University shall mark the candidate as "Admitted Provisionally." Admission letter will be mailed to the candidate.

Similarly 2<sup>nd</sup> and 3<sup>rd</sup> round of allotment will be conducted on the same choices filled by the candidate in the beginning.

Whenever the classes begin, candidate shall carry all originals of all the documents uploaded by him/her. They will be finally verified physically. If any ambiguity is observed, the candidate may be denied admission.


Then the candidate will be required to pay the University's admission fee (minus Rs 10,000 already paid as seat acceptance fee). The seat acceptance fee will be received by the University from ICAR.

Fellowship / Scholarship will be allotted after final admissions are completed by the University.

NOTE:

1. Candidates should visit the official counseling website regularly, for regular updates. Such updates will ONLY be published on this website and through NO other means.

- 2. Since the complete process is Online so candidates should regularly check their email and SMS. No excuse for missing any information will be entertained later.
- 3. Candidates should complete their choice filling / uploading / Online reporting and all online activity just when the facility begins. DO NOT wait for the last date. Verification by University, demand to resubmit some documents and fee reconciliation may take more time than expected. Qualifying in GATE 2021 does not guarantee either an admission to a post-graduate program or a scholarship/assistantship. Admitting institutes may conduct further tests and interviews for final selection.
