- 5. The Educational Advisor will get an amount of Rs 1,08,000/ total in six equal instalments starting from March till Aug 2020. This amount will be finally deducted from the total incentive amount.
- 6. The University shall provide all marketing materials and admission forms which may be required by the Educational Advisor from time to time. Apart from these approved materials Educational Advisor will not use any other printed materials for this program.
- 7. The Educational Advisor would collect the fees from the students only by means of Demand Draft/Cheque or any other digital/direct payment modes communicated by the authorized representative of the agreement to the Educational Advisor in writing in favor of the College/University and should submit the same to the University within a period of 2 days from the receipt of such fees. No other mode of payment would be accepted for collection of fees by the students. The Educational Advisor would not make any commitments with regard to discounting of fess etc. All students have to follow the fees and scholarship matrix provided in www.cutam.ac.in
- 8. The Educational Advisor shall be subject to periodic review every week on Friday by the University.
- 9. The Educational Advisor would adhere to the above said terms and conditions.
- 10. In order for Educational Advisor to perform the consulting services, it may be necessary for the University to provide Educational Advisor with Confidential Information regarding the University's business and products. The University will rely heavily upon Educational Advisor's integrity and prudent judgment to use this information only in the best interests of the University. Educational Advisor will only use such Confidential Information solely in connection with the purposes for which it was disclosed hereunder, and will not disclose, distribute, or disseminate Confidential Information in any way to anyone.







- LL. During the term of this Agreement, the Educational Advisor agrees to be in exclusive service for the University. The Educational Advisor further agrees that, during the term of this Agreement, it shall not provide any similar consulting and services to any other third party without University's prior written consent.
- 12. Even after the termination of this agreement, the Educational Advisor shall be under an obligation not to disclose the Confidential Information to any third party.
- 13. This Agreement will be effective from 17th March 2020 to 16th March 2021 and will be valid for a period of One (1) year only and can be renewed for a further period as per the terms to be decided mutually.
- 14. This Agreement can be terminated by one (1) months prior written notice by either party during the tenure of this Agreement.
- 15. The University reserves the right to terminate this consultancy agreement with immediate effect and forfeit any amount due to the education consultant, if it's found that the Education consultant is in breach of any of the conditions mentioned in para no. 6,9 & 10.
- 16. All Legal Matters will be heard and settled in the City of Bhubaneswar Jurisdiction only.
